Release and Wavier of All Liability
And Assumption of Risk Agreement (Child/Guardian)

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in Ladera Angels Inc., dba Ladera Legs or K&J Racing LLC Events, LARMAC, LARCS and related activities ("Event"), I, for myself, my successors, heirs, assigns, executors, administrators, spouse, and next of kin:

1. Agree that, prior to participating I will inspect the facilities, equipment, and area to be used, and if I believe that any of them are unsafe, I will immediately advise the person supervising the EVENT, facility, activity, or area;
2. Acknowledge that I fully understand that my **participation may involve risk of serious injury or death**, including economic losses, which may result not only from my own actions, in-actions, or negligence, but also from the actions, in-actions, or negligence of others, the conditions of the facilities, equipment, or area where EVENT or activity;
3. **Assume any and all risk** of bodily injuries to myself, including medical or hospital bills, permanent or partial disability, serious physical and/or mental trauma or injury, death and damages to my property, caused by or arising from my participation in EVENT or activity;
4. **Covenant not to sue or present any claim** for personal injury, property damage, or wrongful death against Ladera Legs, Ladera Angels, K&J Racing LLC, the City of Ladera Ranch, LARMAC, LARCS their officers, employees, volunteers and agents for damages attributable to my participations in EVENT or activity;
5. **Release, waive, discharge, and relinquish** Ladera Legs, Ladera Angels, and K&J Racing LLC (PERMITEE/SPONSOR), The City of Ladera Ranch, LARMAC, LARCS, their officers, employees, volunteers and agents from any liability, loss damage, claim, demand, or cause of action against them arising from or attributable to my participation in EVENT or activity, whether same shall arise by their negligence or otherwise;

Agree that photographs, pictures, slides, movies or videos, of me may be taken in connection with my participation in EVENT or activity without compensation from the City of Ladera Ranch, LARMAC, LARCS, Ladera Legs, Ladera Angels, and K&J Racing LLC (PERMITEE/SPONSOR), and consent to the use of these photographs, pictures, slides movies, or videos for any legal purpose.
7. Warrant that I am in good health and have no physical condition that would prevent me from participation in this EVENT or activity; and
8. Acknowledges that the City of Ladera Ranch LARMAC, LARCS, Ladera Legs, Ladera Angels, and K&J Racing LLC (PERMITEE/SPONSOR) are not joint sponsors, joint ventures, and partners or otherwise jointly engaged in the above-named EVENT or activity.

I HAVE READ THIS DOCUMENT, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS AND ASSUME ALL RISK BY SIGNING IT, AND SIGN VOLUNTARILY.

Accident Waiver and Release of Liability

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss.
